Water Safety:

All Operators of motorized vessels, regardless of age, are now required to have a boating safety certificate. Certificates are required for recreational boaters using motorized vessels, including personal watercraft. Operators of non-motorized boats, such as kayaks and canoes, are not required to have a boating safety certificate at this time.

Other things to know about Boating Safety Certificates

- New York recognizes the boating safety certificate issued by your home state.
- Persons may rent and operate a motorboat from a livery without first obtaining a boating safety certificate. Staff at the livery must provide basic instruction and safety information before you depart the dock.
- Operators of non-motorized boats are encouraged to take a safe boating course

New York State Adventure License

If you have a lifetime recreation certificate or sporting license, your New York State Driver License can now become an <u>all-purpose ID card (click for more info)</u>.

Garbage Collection:

As was recently announced, there will no longer be a stationary trash collection. All residents will need to either use trash cans placed at the curb or at the end of private roads, or carry out trash to the transfer station or home. We understand this is a significant change. Let's come together as a community and work to keep our areas neat by following the below guidance: **Logistics to make this as pleasant as possible:**

- Use quality cans and label both the can and the lid with name and camp number
- Bring trash out Monday morning by 9 AM, not the night before, to minimize wildlife issues
- No uncontained plastic bags! If you can't use the trash service with cans, please take your garbage to the transfer station or take it home for disposal Carry in/Carry out!
- Place cans at the end of each private road so not all cans end up at the Higby Point/Crag Point intersection
- South Bay Road should place the cans at the Higby Rd end
- North Shore Residents should use the shoulders beyond the PO Dock parking areas
- Retrieve cans after collection, timely on the same day

- Respect our members and do not place cans directly in front of residences
- Do not block mailboxes
- If you have renters please communicate these guidelines to them.

From the Town of Webb:

- Clear bags must be used for garbage. Bags that cannot be seen through will not be picked up
- You must separate your recyclables from your garbage. Recycling for pickup should be bag-less in a recycling bin with a decal; decals are available at the Information Center. Cardboard must be cut into pieces smaller than 3' X 3'.

Youth Protection Training: Youth Protection training continues to be a vitally important part of our culture and mindset. We strongly encourage our membership, regardless of whether they have kids participating in programs, to take the training. It is very informative and relevant to our home lives and well as our lives here in Big Moose. The training can be found and http://mv.scouting.org Follow the prompts to create an account and begin the course.

Emergency Services and CPR/First Aid Training:

We continue to be serviced by the Big Moose Volunteer Fire Department and its new boat, as well as the Old Forge Volunteer Ambulance.

We all know that even with the best of response times, we are in a remote area, and it takes time for the ambulance to arrive. Our best offense is a good defense – learning CPR and First Aid to help should an issue arise. To that end, Steve Baker will be teaching the American Heart Association's CPR and First Aid course. The course will be held over 2 evenings, Sunday, July 13th and Monday July 14th from 6-9 PM both nights. There is a small cost for materials. The class size is small, with 9-12 people. A sign up sheet will be in the Association Center beginning the 4th of July weekend.

Water Quality:

Dye testing: The Town of Webb Dye Testing of septic systems will continue. There is no cost to you for these tests. The BMPOA covers the cost. The goal is to test properties approximately every 3 years to assure properly functioning septic systems.

ALAP Update: The Adirondack Lake Assessment Program is conducted annually, testing for approximately 15 water quality variables (e.g., Chloride, Alkalinity etc.). The results are typically available after the new year. Our results have been consistent year over year, however we are still waiting for the new results.

Additionally, coliform testing, with sampling twice a summer across 20 different locations in the lake, yielded good results.

Invasive Species:

Prevention remains the #1 Priority

Continued diligence by each of us by inspecting our own and our guests' watercraft (including boats, jetskis, canoes, kayaks, sailboats, etc.) is critical in helping us maintain an invasive free lake. Special thanks to Dunn's for providing inspection services. Dunn's will inspect all boats not from this lake upon entry, regardless of whether it has been inspected/tagged at one of State boat washing centers. If you have renters, please educate them on this important topic.

After Prevention, Early Detection is the most Critical Goal

Kurt Pardue continues to conduct an annual lake swim to look for invasives. The lake swim has been the foundation of our ongoing invasives prevention strategy for many years.

In addition, this year the BMPOA will engage Adirondack Research to perform a professional, comprehensive invasives survey of Big Moose Lake. The lake was last surveyed by this group in 2022.

Surveys are done in a zig-zag pattern, searching for **aquatic plant beds** using visual and sonar detection from shoreline to a depth of about 15 feet. For **aquatic invasive animal detection**, sediment sieves are used to search for invasive mollusks. Plankton tows are done on each lake to search for invasive planktonic crustaceans, such as the spiny waterflea. Maps are then produced, outlining findings. This survey is an important part of BMPOA's strategy of early detection of invasive species.

Another way to detect invasives is the **Lake Protector** program -where participants can be citizen scientists and help monitor the lake for invasive species. The Lake Protectors program involves attending online training, adopting and monitoring a section of the lake at least once a summer and reporting your findings back to APIPP.

The more people we can activate to monitor protect our lake, the more likely it is that we can quickly eradicate any invasives found. Follow this link for additional **Lake Protector Information**

We often think of invasives in the aquatic sense, but **terrestrial invasives**, like Knotweed, are an issue too. APIPP can help remediate this, free of charge. **Read more about knotweed management here.**
